Therefore, the following conditions and agreements must be met in order for the Youth/Teen member participation.

Disclaimer of Liability:

Skiing and Snowboarding are athletic activities that involve inherent risk of injury and death. Pocatello Ski Association is not, under any circumstances, responsible for injury or death of any participant while involved in a PSA governed activity.

Conditions of Participation:

1. Each participant of PSA activities must hold a current **paid membership.**
2. Each participant must **present this parent or legal guardian signed consent** at the start of each trip or activity that requires such consent.
3. Each participant must have **medical insurance as verified by the parent or legal guardian.**
4. Each participant must agree to obey all laws and codes of conduct specific to the site of the ski area, resort facilities, and businesses patronized by Pocatello Ski Association which includes the commercial carrier that provides the transportation.
5. Each participant must agree to obey all PSA activity guidelines and recognize the organizers of the PSA Youth/Teen Ski/Board Program as the overriding authorities.

Pocatello Ski Association Youth Ski/Board Program Guidelines:

1. Participants under the age of **12** must be accompanied by **an adult.**
2. **FULL Cost** of the PSA activity must be paid at the time of sign up.
3. Money paid toward a PSA activity **cannot be refunded** unless that seat can be sold to another participant.
4. **Use of tobacco, illicit drugs or alcohol while involved in a PSA Youth/Teen activity is PROHIBITED!**
5. Participants who violate the Youth Ski/Board Program Guidelines and/or Conditions of Participation are subject to **corrective action** (s) by the PSA Youth/Board Activity organizers. It can include loss of skiing/boarding privileges and/or termination of activity participation.
